## ACO CAHPS Survey—Press Ganey

One requirement from CMS for being an accountable care organization (ACO) in the Medicare Shared Savings Program (MSSP) is that we partner with a CMS-approved vendor for the administration of the Consumer Assessment of Healthcare Providers and Systems (CAHPS) survey. The CHPA BOD approved Press Ganey as CHPA's vendor for the 2017-2018 ACO CAHPS survey. CHPA has provided a demographic profile to Press Ganey to determine the ACO's peer group for future comparisons and expects a summary report in April 2018.

Press Ganey has begun the administration of the survey. The CMS pre-notification letter was mailed to the 860 randomly selected beneficiaries on November 8, 2017. The initial mail survey has been mailed November 15, 2017. The second mail survey is to be mailed December 12, 2017. Please do not hesitate to reach out with any questions regarding this process.
